

## Terms of Service

### 1. Introduction; Your Agreement to these Terms of Service.

PLEASE READ THESE TERMS OF SERVICE CAREFULLY. THIS IS A BINDING CONTRACT. Welcome to the services operated by POSEIDON 133 PTE. LTD. (with its affiliates, “**Gunzilla**”) which enables users to send and accept and earn game token GUN, in game objects in the form of NFT and use other available services in the wallet (the “**Gunzilla Services**”). Other services offered by Gunzilla may be subject to separate terms.

GunZ wallet is not a regulated custodian services provider and cannot be treated as such.

GUN token is game token build on GUNZ chain and not to be consider cryptocurrency, digital asset or reward points.

GUN token can not be transfer or withdraw anywhere outside GunZ wallet.

The information on the Site, the App, and the Smart Contracts are not intended for distribution to any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation, or which would subject us to any registration requirement within such jurisdiction or country. Accordingly, any persons who access the Site and/or the App while breaking their local laws are doing it on their own initiative and will have to deal with the consequences when applicable.

The App is intended for users who are at least 18 years old. People under the age of 18 are not permitted to use or register for the Site, and the App.

1.1. When using the Gunzilla Services, you will be subject to Gunzilla’s Privacy Policy, and you be subject to additional guidelines or rules that are posted on the Gunzilla Services or made available to you, or applicable to specific services and features that are disclosed to you in connection with such services. You acknowledge that you have read, understood, and agree to be bound by these Terms of Service. If you do not agree to these Terms of Service, do not access or otherwise use any of the Gunzilla Services.

1.3. Any new features or tools which are added to the service shall also be subject to the Terms of Service. You can review the most current version of the Terms of Service at any time on this page. We reserve the right to update, change or replace any part of these Terms of Service by posting updates and/or changes to our application. It is your responsibility to check this page periodically for changes. Your continued use of or access to the website following the posting of any changes constitutes acceptance of those changes.

*The TECHNOCORE mobile game will exclusively be accessible to users who have previously signed up for the waitlist. All eligible users will receive an initial NFT and game tokens upon gaining access to the game.*

## **2. General Conditions.**

*We reserve the right to refuse service to anyone for any reason at any time.*

2.1. You understand that your content, may be transferred unencrypted and involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices.

2.2. You agree not to reproduce, duplicate, copy, sell, resell, or exploit any portion of the Service, use of the Service, or access to the Service or any contact on the application through which the service is provided, without express written permission by us.

2.3. The headings used in this Agreement are included for convenience only and will not limit or otherwise affect these Terms.

2.4. Gunzilla operates in game wallet which enable users to open in game objects (Data-Cube) inside the application, send object to the other user including the Gun token.

2.5. You understand that GunZ token is in-game token and cannot be withdrawal anywhere outside of the game ecosystem.

## **3. Gunzilla Users**

*“Gunzilla Product”* Gunzilla offers the user a software solution which allows send and receive game token from the other users, decode Data-Cubes, send and receive in game objects.

*“User”* any person who created account in GunZ wallet in accordance to this Terms.

*“Validators”* are users within the game who possess the ability to decode data-cubes. They have specialized knowledge and tools that allow them to decrypt the encrypted data contained within the data-cubes.

*“Data-Cubes”* these are in-game objects that contain encrypted data.

## **4. Use of Gunzilla by Minors and Blocked Persons.**

The Gunzilla Services are **not available** to persons **under the age of 18**. The Gunzilla Services are also not available to any users previously removed from the Gunzilla Services by Gunzilla. Finally, the Gunzilla Services are not available to any persons barred from receiving them under the laws of Singapore and the European Union or applicable laws in any other jurisdiction.

BY DOWNLOADING, INSTALLING, OR OTHERWISE USING THE GUNZILLA SERVICES, YOU REPRESENT THAT YOU ARE AT LEAST 18 YEARS OF AGE, AND THE AGE OF LEGAL MAJORITY IN YOUR JURISDICTION OF RESIDENCE, AND THAT YOU HAVE NOT BEEN PREVIOUSLY REMOVED FROM OR PROHIBITED FROM RECEIVING THE GUNZILLA SERVICES.

## **5. TECHNOCORE mobile game.**

5.1. The Technocore mobile game is to enable users to find and decode data-cubes using the GunZ Wallet app. Users download and install the GunZ Wallet app on their mobile devices. Data-cubes are scattered throughout the game environment.

5.2. Users start at a designated starting point after installing TECHNOCORE game. The users explore the game environment to find data-cubes. Once a user finds a data-cube, they can request its decoding through the GunZ Wallet app. Validators within the app are responsible for decoding the data-cubes and revealing the encrypted data to the user. To decode a data-cube, the user needs to request decoding through the GunZ Wallet app and follow the instructions provided by the validator. If the user successfully decodes the data-cube, they receive the decrypted data and can proceed with the game. Users can decode multiple data-cubes using the GunZ Wallet app., can exchange in-game object with the other users after decoding. Once a data-cube is decoded, it remains decoded for the duration of the game. Other users can't decode the same data-cube again. The game environment can be customized to provide challenges, puzzles, or clues that lead users to the data-cubes.

5.3. All items inside the TECHNOCORE mobile game and GunZ wallet, such as NFTs and/or Gun tokens, can only be used and stored within the Gunzilla ecosystem and cannot be transferred or withdrawn outside of the Gunzilla ecosystem.

## **6. Privacy Policy.**

Your privacy is important to Gunzilla. Please see our Privacy Policy for information relating to how we collect, use, and disclose your personal information, and how you can manage your online privacy when you use the Gunzilla Services.

## **7. Account and Password.**

7.1. To use our Services, you must register and create an account. You are responsible for maintaining the confidentiality of your account and password and for restricting access to your account. You must immediately notify us if you become aware of any unauthorized use of your account or password.

7.2. In order to use certain features of the Gunzilla Services you might have to pass KYC using our KYC provider.

7.3. You are solely responsible for all information provided by you to the KYC provider. You are clearly understand that by providing false information, fake documents or documents which belong to the other person you are committing crime and you can be prosecute in fraud by the law enforcement.

## **8. List of the countries under sanction which are blocked:**

Iran, North Korea, Syria, Sudan, Cuba, Venezuela, Crimea, Sevastopol, Afghanistan, Yemen, Somalia, Zimbabwe, Nicaragua, Mali, Libya, Lebanon, Iraq, Central African Republic, Congo, Burundi, South Sudan, Kosovo, Artsakh, Northern Cyprus, Abkhazia, Transnistria, the Sahrawi Republic, Russian Federation, Donetsk and Luhansk regions of Ukraine. Use of the application for the citizens of the above countries is prohibited.

#### **11. Waiver.**

If we fail to exercise or enforce any right or provision of these Terms of Service, it will not constitute a waiver of such right or provision. Any waiver of any provision of these Terms of Service will be effective only if in writing and signed by the relevant party.

#### **12. Compliance with Intellectual Property Laws.**

When accessing or using Gunzilla, you agree to obey the law and to respect the intellectual property rights of others. Your use of Gunzilla is at all times governed by and subject to laws regarding copyright, trademark, patent, and trade secret ownership and use of intellectual property. You agree not to upload, download, display, perform, transmit, or otherwise distribute any information in violation of any party's copyrights, trademarks, patents, trade secrets, or other intellectual property or proprietary rights. You agree to abide by laws regarding copyright, trademark, patent, and trade secret ownership and use of intellectual property, and you shall be solely responsible for any violations of any laws and for any infringements of any intellectual property rights caused by your actions, post, or transmit, or that is provided or transmitted using your user name or user ID.

#### **13. Limitation of Liability**

In the event that any provision of these Terms of Service is determined to be unlawful, void or unenforceable, such provision shall nonetheless be enforceable to the fullest extent permitted by applicable law, and the unenforceable portion shall be deemed to be severed from these Terms of Service, such determination shall not affect the validity and enforceability of any other remaining provisions.

#### **15. Governing Law.**

Gunzilla reserves the right to discontinue or modify any aspect of the Services at any time. These Terms and the relationship between you and Gunzilla shall be governed by and construed in accordance with the laws of Singapore, without regard to its principles of conflict of laws. Subject to the foregoing, you agree to submit to the personal and exclusive jurisdiction of the courts located in Singapore and waive any jurisdictional, venue, or inconvenient forum objections to such courts, provided that (i) Gunzilla may seek injunctive relief in any court of competent jurisdiction and (ii) in the event of any dispute relating to payments processed through Gunzilla, such dispute shall be heard in the courts of Singapore.
